Message from the Founder and Executive Director, LAUREN NOBLE '11

As the summer winds down, I am thrilled to share with you the Buckley Program's 2016-2017 Annual Report. Reflecting on our activities throughout the past year, I am deeply encouraged by the steady growth in our programming and the surging student demand. Not only did our number of student fellows rise to 283, but we also attracted record crowds to our lectures and hosted more events than ever before.

In the recently released second edition of the *Heterodox Academy Guide to Colleges*, which rates universities by viewpoint diversity, Yale ranked eleventh from the bottom out of 106 institutions. While that assessment is unsurprising, more concerning is the environment students encounter. Last fall, the *Yale Daily News* reported that three quarters of students found Yale unwelcoming to conservatives. Our own survey findings confirm that general perception of the campus intellectual climate. The Buckley Program cannot solve this problem alone, but our efforts are making a real difference.

I invite you to take a few minutes to read the pages that follow and learn about our impact on the campus discourse and in the education of many students. The regular episodes of dysfunction, intolerance, and overreaction at colleges and universities nationwide are common fodder for ridicule. Much of the effectiveness of the Buckley Program can be attributed to the fact that instead of merely responding with whining about political correctness or a lack of conservative voices, we offer a positive alternative. We expose students to the principles William F. Buckley, Jr. championed, puncture campus echo chambers, and model debates and discussions that are civil, open, and honest.

Our multi-day seminar program has truly flourished. These seminars give students the opportunity to study with top teachers over Yale's fall and spring breaks. This past academic year's subjects were the morality of capitalism and Alexis de Tocqueville's *Democracy in America*. As a result of glowing student feedback, this coming year we've doubled the number of seminars, adding one in August and another in January.

We have many exciting programs in store for this year, including our Seventh Annual Conference on Friday, November 3rd. I hope you can join us then or at another event. Finally, I am truly humbled by the generosity you've shown our cause. Contributions and revenue last year totaled \$818,461, a significant boost from 2015. Quite simply, our work would not be possible without your support. Thank you very much.

The Buckley Program welcomed 140 new student fellows during the past school year. This milestone highlights how the Program's mission has resonated so well with Yale's undergraduate and graduate students. As I think back to my first Buckley Program event in the fall of 2014, I recall having no idea that debates about free speech were common on college campuses today. But in my short time at Yale, I have witnessed no shortage of controversy, and the Program's leadership on free speech issues has no doubt accelerated its growth.

The Buckley Program now boasts over 280 fellows from across the political spectrum, and I have been especially pleased to welcome students who value free speech as a foundational aspect of our society. Regardless of ideology, many Yale students are hungry for intellectual diversity on campus.

Even when they disagree, dozens of students and community members regularly attend our events because they value the discourse we provide. A great memory from this past year was witnessing hundreds of people wait to hear Dr. Ben Carson speak in SSS 114. The capacity crowd did not interrupt him, for his words captivated the audience. At a time when certain speakers lament the possibility of being shouted down, this event reinvigorated my faith in the smart programming that the Buckley Program pursues. Similarly, my favorite event was the lecture we hosted with New York Times best-selling author J.D. Vance in February of 2017. A record-breaking 800 guests joined us to hear him speak about his childhood lessons and Appalachian roots. Not only did the event resonate with me as a Tennessean, but it was also wonderful to see so many engaged in learning more about the region's fiscal challenges and partisan upheavals. We need speakers on college campuses who represent both sides of the aisle, and the Buckley Program provides balance to Yale's campus.

Given the current global political climate, the mission of the Buckley Program remains more important than ever. Many fellows have shared that their intellect has developed tremendously due to programming that not only articulates their views, but also challenges their prior assumptions. I speak from the heart when I express how thankful I am to have found the William F. Buckley, Jr. Program at Yale, and I sincerely thank you all for your generous support.

LECTURE SERIES

Our public events continue to attract undergraduates and graduate students alike as well as other members of the Yale and New Haven communities. This past year, we filled one of Yale's largest lecture halls, SSS 114, multiple times. For example, our event with Dr. Ben Carson was so popular that we had to turn away an estimated 400 people at the door due to lack of space. We rented the ballroom of a local hotel to accommodate the incredible interest we received in our event with best-selling author J.D. Vance, which ended up drawing nearly 800 people.

A number of our events garnered media coverage, from the Yale Daily News to national publications and local television. We also filmed many of the programs. The video footage is available to watch on our YouTube channel and has received thousands of views online.

FIRING LINE DEBATES

Many people had their first exposure to Bill Buckley and his ideas through his television show, Firing Line, launched in 1966. We are proud to keep this memory alive with our Firing Line Debate Series. Over the past several years, we've brought together academics, think tank fellows, and former government officials for charitable and engaging discussions on a host of issues.

In the 2016-2017 academic year, we hosted five debates, on topics ranging from healthcare policy to school choice. These debates often drew students and community members who might not otherwise attend Buckley Program activities. For example, our debate on climate policy attracted students from the School of Forestry.

We look forward to continuing this popular series during the fall semester of 2017, with debates already scheduled on Brexit and Iran.





MULTI-DAY SEMINARS

Our multi-day seminar program has thrived since its inception in the spring of 2015. These seminars allow students to study important texts and ideas for three days during Yale's academic breaks. Admission to seminars is by application and we have been pleased to welcome both undergraduates and graduate students of varying academic fields.

Over fall break in October 2016, we hosted a seminar on the morality of capitalism taught by Professor James Otteson of Wake Forest University. Seventeen students participated in this seminar, which covered thinkers such as Adam Smith, John Locke, and F. A. Hayek, among others.

During spring break in March 2017, we hosted a seminar on Alexis de Tocqueville's *Democracy in America* taught by Professor Patrick Deneen of the University of Notre Dame. Twenty-one students participated in the seminar. We received so much interest that we even had to wait list some students. One student put forward this powerful endorsement afterward:

Simply put, I get more out of these three-day seminars than a half-semester of most Yale classes, and I am at Yale to learn. The rigorous academic environment paired with the social aspect (I make several new friends every seminar!) makes these seminars a real version of what I imagined Yale would be like.

In light of this student enthusiasm, we are excited to double our multi-day seminar offerings this year. In late August, Professor Bradley Birzer of Hillsdale College taught a seminar focusing on the thought of Edmund Burke and Russell Kirk. Dr. Michael Uhlmann of the Claremont Institute will teach our fall break seminar this year on the American presidency. And in January, best-selling author Amity Shlaes will teach our second seminar addition on William Graham Sumner and "The Forgotten Man."


STUDENT FELLOWS PROGRAM

In the 2016-2017 academic year, we saw incredible growth in our student fellows program. We recruited 140 new students, expanding our student membership to 283 students. That is a record number and an increase of over 100 students from our total at the end of the prior academic year.

Our student fellows receive access to special opportunities including seminars, dinners and receptions with guest speakers, free books, and subsidized opportunities to attend conferences such as the Conservative Political Action Conference.

This year, our fellows-only seminars featured Carol Platt Liebau, Sally Satel, Charles C. W. Cooke, and Mary Eberstadt. Held over dinner, these seminars gave student fellows the chance to engage with speakers and material in a more in depth way than a lecture might permit. Topics ranged from religious liberty to Connecticut's fiscal challenges.

Our fellows also once again participated in a community service project. Through Splash at Yale, they taught short seminars on a variety of subjects for high school and middle school students.



INTERNSHIP PROGRAM

Through its summer internship program, the Buckley Program sponsored Yale students at a variety of publications and think tanks. In the summer of 2017, we sponsored Yale undergraduates at National Review, The New Criterion, the Manhattan Institute, and Gingrich Productions. Each intern received a stipend of \$4,000, making the experience affordable to students of all backgrounds.

The program has a competitive application process, coordinated through the Yale Office of Career Strategy. Each position received an average of 19 applications. We also funded two partial stipends for two Yale students interning at *First Things* and the Cato Institute.




STUDENT BLOG

YALE STUDENT SURVEY

In April 2017, we commissioned a survey of Yale student attitudes toward free speech and intellectual diversity. We mailed the results to Yale alumni and other supporters. The findings were also covered in *The Wall Street Journal, New Haven Register, The Washington Times*, and *New York* magazine, among others.

ANNUAL NATIONAL STUDENT SURVEY

In the fall of 2016, for the second year in a row, we commissioned a national poll of college students. Conducted by McLaughlin & Associates, this survey tested students' civics knowledge as well as attitudes toward free speech and related issues. Among other notable results, the survey found that more than half (53%) of U.S. college students felt intimidated in sharing beliefs that differ from those held by their professors. This number was up by four percentage points from the previous year. We will continue to monitor this "Classroom Intimidation Index" in the years to come. We plan to release another poll later this year.

ALUMNI TRUSTEE INTIATIVE

In April 2017, the Buckley Program organized a petition calling for more information about where the Yale trustee candidates stand on the critical issues of free speech and intellectual diversity on campus. Over 400 alumni signed the petition, which received coverage in the *Yale Daily News* and *The Wall Street Journal*. Buckley Program executive director Lauren Noble and board member Richard R. West published an op-ed arguing in favor of repealing the gag rule Yale imposes on trustee candidates, noting:

But the current process is unfair to the candidates and the alumni. If university administrators will not provide the basis for both groups to help ensure an informed choice of trustees, what is the purpose of having an election?

American Council of Trustees and Alumni President Michael Poliakoff also released a statement in support of our petition, explaining:

By preventing trustee candidates from providing any information beyond biography, Yale is preventing alumni and students from participating in the board election in an informed and engaged manner. Controversies involving free speech have recently roiled Yale, and it's therefore no surprise that alumni are disappointed by the obstacles on campus to free expression. A healthy campus community rests upon shared governance and open communication. The board and university administration should lift the gag order and embrace a fairer election process that allows the alumni community to hear the ideas of the candidates in a free exchange of viewpoints.

The Buckley Program will continue to make the case for greater attention to these substantive issues in the trustee election process.



WOODWARD REPORT REPRINT



In the fall semester of 2016, we released the second "William F. Buckley, Jr. Program at Yale Book," which was a reprint of and commentary on the Woodward Report, Yale's policy on free expression published in the 1970s. Encounter Books published this booklet, titled *Campus Speech in Crisis: What the Yale Experience Can Teach America*. We hosted a book launch reception in October 2016 featuring remarks by Judge José A. Cabranes.

Throughout the year, we distributed copies to students on campus, including at the freshman activities bazaar. We continue to hand out copies of the booklet at various events such as our alumni reunion weekend panel discussions.

ESSAY CONTESTS

In October 2016, the Program offered an essay contest on the question, "Where is the American political party system headed after 2016 and why?" There were two contests: one for Yale College students and one for high school students. The winners received monetary awards at the November conference. The high school winners attended the event with their parents.

In March 2017, the Program offered another essay contest on the question, "What can we learn from William F. Buckley, Jr. today?" There were again two contests: one for Yale College students and one for high school students. The winners received monetary awards at our event examining Alvin Felzenberg's new biography of William F. Buckley, Jr.
